REDEVELOPMENT OF 6 (SIX) PORTS OF ENTRY THROUGH A PUBLIC PRIVATE  
PARTNERSHIP (“PPP”)**

1. Words and expressions that are capitalised and not defined in this invitation or advertisement shall bear the same meaning given to them in the RFP and/or PPP Agreement.
2. The Department of Home Affairs (“**Department**”) hereby invites Bid Responses from entities that are interested to participate as Private Parties to design, redevelop, finance, construct, operate, and maintain, and provide supporting infrastructure for broadband connectivity to 1 (one) or more of the 6 (six) Designated Ports of Entry on a PPP basis.
3. A non-refundable bid document fee of R25 000 (twenty-five thousand Rand) is payable prior to release of the bid document. This fee must be paid to the DHA’s bank account, the details of which are as follows:
